

Standard/Micro/Nursery Cultivation Licence Overview

Under the *Cannabis Act*, businesses that are looking to cultivate cannabis are required to hold one of the following licences:



1. Standard Cultivation Licence

This licence is best for cultivators looking to grow on a large scale because there are no restrictions on grow space.



2. Micro-Cultivation Licence

This licence is best for cultivators looking to grow on a small scale, as the licence permits cultivation in a grow space of up to 2,152 square feet.

3. Nursery Licence

This licence is best for cultivators looking to supply small and large scale cultivators with starting materials, as the licence permits the cultivation of cannabis genetics such as clones and seeds.



Standard/Micro/Nursery Cultivation Licence Overview



Those who hold a Cultivation Licence (Standard or Micro) can conduct the following activities:

- Possess cannabis
- Obtain dried or fresh cannabis, cannabis plants or cannabis plant seeds by propagating, cultivating, harvesting
- For the purpose of testing, alter the chemical or physical properties of the cannabis
- Sell and distribute dried/fresh cannabis, cannabis plants or plant seeds to other licence holders
- Conduct ancillary activities (e.g., drying, trimming, milling, etc.)

Those who hold a Nursery licence can conduct the following activities:

- Possess cannabis
- Obtain cannabis plants or cannabis plant seeds by propagating, cultivating, harvesting
- For the purpose of testing, alter the chemical or physical properties of the cannabis
- Sell and distribute cannabis plants or cannabis plant seeds to other licence holders
- Conduct ancillary activities (e.g., drying)

Steps to Submit a Cultivation Licence Application



It is crucial that your site evidence package and your application documents in CTLS are both complete, accurate and correlating. Health Canada may refuse to consider an application if any of the required information is not provided. Submitting an incomplete or "messy" application can slow down the review of your file, which will ultimately result in extra waiting time for you to receive your licence.

Key Considerations for your Business

Individuals to be Listed on the Application

Cultivation Licence Holders (Standard, Micro, Nursery) are required to identify certain key individuals as part of the licence holder. These individuals are:

1. Responsible Person

The Responsible Person has overall responsibility for the activities conducted by the licence holder and must have sufficient knowledge of the provisions of the Act and Regulations that apply to the licence holder.



The Head of Security is responsible for ensuring that physical security measures comply with Part 4 of the Cannabis Regulations as well as the company's Organizational Security Plan (OSP).

3. Master Grower

The Master Grower is responsible for the cultivation, propagation and harvesting of cannabis and must be familiar with the provisions of the Act and Regulations that relate to his or her activities.
