CRC: Cannabis Regulatory Commission

Secure your Licenses and Authorizations

The Cannabis Regulatory Commission (CRC) has responsibility for regulating cannabis retail stores in the State of New Jersey under the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization (CREAMM) Act of 2021. To open and operate a cannabis retail store and sell recreational cannabis, you must obtain a Class 5 Retailer license. There are two pathways to obtaining a license. You can either 1) apply for a conditional license and convert to an annual license during the 120-day conditional license period; or 2) directly apply for an annual license. Conditional licenses are beneficial as they allow applicants time to complete all regulatory requirements for an annual license and are granted priority review by the CRC.

1. Cannabis Retail Conditional License

To obtain a conditional license the CRC will review and score your application in the order submitted. Priority review will be granted to Social Equity, Diversely-Owned, and Impact Zone businesses. Applicants that meet the eligibility criteria set out in the CREAMM Act and N.J.A.C. 17:30 will be awarded a conditional license.

2. Cannabis Retail Annual License

Once businesses obtain a conditional license they will have 120 days to convert to an annual license.

Conditional licensees may apply for a 45-day extension granted on a case-by-case basis by the CRC. Businesses must pass a facility inspection before final approval of the annual license is obtained.

Class 5 Retailer Conditional License

To submit an application for a Class 5 Retailer conditional license, you must pay an application submission fee of \$200 and a conditional license approval fee of \$800.

To be eligible for a Class 5 Retailer conditional license, you must meet the following criteria:

- Register your legal entity that will hold the license with the State of New Jersey Division of Revenue and Enterprise Services in the Department of Treasury and obtain a Federal Employer Identification Number (FEIN).
- Determine whether your business qualifies as a Social Equity, Diversely-Owned, or Impact Zone business.
- Identify a proposed retail location. The retail location must be secured during the 120-day conditional license period.
- Prepare a full Business Plan which includes the description of your business, how you will execute the goals
 of your business, management profile(s), and a financial plan detailing your budget and overview of
 proposed financing to fund the operational costs of your business.
- Prepare a Regulatory Compliance Plan detailing how your business will comply with the laws of the CREAMM Act and the rules and regulations for cannabis businesses under N.J.A.C. 17:30.
- Prepare a plan for how your business will obtain liability insurance.
- Each owner has an adjusted gross income of no more than \$200,000 or \$400,000 if filing jointly for the previous tax year.
- Disclose all persons and entities who hold interest in the business. At least one owner must have been a New Jersey resident for at least two years.

Class 5 Retailer Conditional to Annual Conversion License

To submit an application for a Class 5 Retailer conditional to annual conversion license, you will pay a conditional conversion submission fee of \$200 and an approval fee of \$800. Once the application is approved the annual license fee for a Class 5 Retailer is \$10,000.

To be eligible for a Class 5 Retailer annual license, you must meet the following criteria:

- Secure a business location that is compliant with local codes and ordinances in regards to zoning and distance setback requirements from any specified sensitive use sites such as, schools, playgrounds, day care centers or places for religious worship.
- Obtain approval from the local municipality where your dispensary will be located in the manner as determined by the local municipality.
- All owners with decision making authority must submit to a background check verifying the individual's criminal history does not include a disqualifying offense.
- Provide a Financial Plan and sources of funding.
- Prepare a Site Plan detailing the layout of the business and a description of its suitability to meet the
 operational and safety needs of your business.
- Prepare Standard Operating Procedures (SOP).
- Prepare an Environmental Impact Plan, Safety and Security Plan, Community Impact Plan, and a Workforce Development and Job Creation Plan.
- Pass a facility inspection. Successful completion of the facility inspection will result in issuance of an annual license and payment of the annual license fee. Once the license fee is paid you're ready to open for business!


